ONLINE INSTRUCTIONS FOR CONTINUING EDUCATION CREDIT

1. **Create an account Or Login** if you already have an account.

NOTE: Entering incorrect data will result in a rejection of CPE credit by CPE Monitor. Carefully check your NABP e-Profile ID and date of birth (MMDD) to ensure this data is accurately recorded! If you have any questions regarding how to set up your NABP e-Profile and registering for the CPE Monitor service to ensure your CPE units are properly tracked for licensure, visit: <https://nabp.pharmacy/>

2. **Select** “Pending/Private Programs” and at the top of the page
3. **Enter** the following registration code at the bottom of the page:

4. You should now be on the continuing activity page, **Stress, Thyroid, Adrenal Connection**
 - a. **Review and select** “Register Now”
 - b. From the Register Now page, **confirm your account information is entered correctly**, and click “Register”.
 - c. A notice on the activity page will confirm you have been registered for the program. **PLEASE BE SURE TO REGISTER FOR THE CORRECT ACTIVITY, there may be both a pharmacist and a technician option!**
5. After attending/viewing this activity you must **complete** the Post Test (if required, and achieve a passing score of 80 percent or higher, you can re-take as needed).
 - a. **Select** “Take the Test” and then “Grade my Test”. If you do not pass with 80%, retake the test. **If the test is not required, go to step 6.**
6. **Complete** the evaluation to claim CPE credit.
 - a. **Select** “Complete Evaluation”
 - b. **Do not leave any question unanswered. If you do not have a comment or do not feel you want to answer the question, please put “NA” in the space provided.**
7. After successfully completing the evaluation, you will be able to print your Statement of Continuing Pharmacy Education Credit if desired. Under the “View/Print CE Credit” tab, a list of your completed CEs will appear.
 - a. **Always check your CPE Monitor account to verify your credit has been accepted.**

IMPORTANT: You must complete all the above requirements by 30 Days POST ACTIVITY. Failure to do so will result in a loss of Continuing Pharmacy Education Credit. A system wipeout clears all pending activity into CPE monitoring during this time, so it is imperative that you complete your evaluations within the allotted time frame.
